This research delves into the vital role of dynamic leadership in driving the growth and expansion of the World Revival Faith Ministry (WRFM) under the guidance of Oladega Adebogun. It highlights the contributions of grassroots church founders in Nigeria, such as Oladega Adebogun, which are often overlooked in favor of more prominent church leaders. The study identifies a crucial issue: while Nigeria is experiencing rapid church growth, the influence of local leadership on this phenomenon remains poorly understood. The objectives include examining Adebogun's leadership strategies, evaluating their effects on church growth, and understanding community interactions that contribute to spiritual and socio-economic development. Using qualitative methods, the research incorporates case studies, interviews, and direct observations of WRFM's activities. Findings indicate that Adebogun's inclusive leadership approach, characterized by passionate evangelism, sound biblical teaching, and a strong commitment to community engagement, and has led to remarkable growth, with over forty branches established in Lagos and Ogun States by 2025. Furthermore, WRFM's dedication to social responsibility through educational initiatives, humanitarian projects, and economic empowerment has profoundly impacted individual lives and local communities. Recommendations include enhancing leadership development, utilizing technology for outreach, and building stronger community partnerships to ensure sustained growth. This research underscores the significance of dynamic leadership in facilitating holistic church expansion, offering a valuable model for grassroots movements within Nigeria's religious landscape.

The expansion of Christianity in Nigeria is a dynamic combination and interaction of local leadership and culture appropriation. The religion was first brought to the region by Western evangelists in the 19th century; however, it has significantly evolved through local leaders who contextualize the Christian scriptures and teachings to make them relevant to their people (Dean, 2009; Hiebert, 1984). This indigenous form of leadership is made possible by the radical expansion of churches in Nigeria as scholars have also underscored that the relevance of this indigenous leadership can be found at the grassroots, as it is the Local leaders are best positioned to make Christianity more relatable to their communities (Dean, 2009; Hiebert, 1984; Gaiya, 2021). These indigenous leaders do not only evangelize but they also explore the local beliefs, local

practices, the local elements of socio-culture which help them to develop identity, an identity that is distinctively Nigerian. However, this approach may be perceived as diverging from traditional Christian teachings (Metala, 2019; Iweala, 2022). Some of these native leaders include Oladega Adebogun, who founded the World Revival Faith Ministry (WRFM). WRFM has experienced exponential growth since its inception in the year 2010 to date, reaching more than forty-branch expansion in Lagos and Ogun States by 2025 (Soneye, 2025). Such traits of leadership as dynamic approaches to strategies and inclusion of needs of the community, strong evangelism, and adherence to preaching and teaching the Bible make Adebogun one of the major players on the map of Nigerian Christianity (Soneye, 2023). In his style, he is more of an inclusive and mentor-like leader that also helps in developing better ownership among the congregants and spark the burning desire to do outreach and

serve the community. Some research indicates that the aspects of great leadership in the church settings can be noted to have transformational nature in their sense that, they tend to inspire others towards action and towards the contribution of a collective vision (Bass & Riggio, 2006). An analysis of the case study of Adebogun therefore necessitates a reflection along the path towards how his leadership is able not only to make the operations of WRFM efficient but also able to provide solutions to other socio-economic issues other than the residents of the areas where the ministry operates. Dynamic leadership can be defined as a complex leadership method through which society leaders lead, and direct the society through the inspiration process, especially in the context of church growth. The idea extends beyond the field to entail numerous traits, such as vision, flexibility, and the capacity of creating a lively community environment (Northouse, 2018). Effective church leadership extends beyond mere administration, playing a pivotal role in shaping the theological direction and community impact of congregations, thereby influencing the lives of church members and the broader community (Soneye, Abodunrin, & Olorunlana, 2025). Studies always emphasize that the leadership style pursued by the pastors and church founders plays a significant role in defining how churches are able to respond to current challenges facing modern society and support spiritual development among the members of the congregation (Setley & Gautsch, 2015).

Transformational leadership as first analyzed and defined by Burns (1978) as one of the most relevant leadership structures within the context of church development. In comparison to the transactional leader, the transformational leader focuses more on motivating his or her followers so that they attain superior states of motivation and morality. Such leaders in the church growth context know how to develop a very strong vision that will appeal to the needs and dreams of their followers or congregations. Oladega Adebogun is a great example of such a style, and his ability to train and equip others within the World Revival Faith Ministry (WRFM) is what has helped create a culture of self and community development (Soneye, 2025). The primary aim of Adebogun to generate future leaders in his ministry has made the church to have a good foundation of continuous impacts. This approach does not only improve personal spiritual walk but it also produces a growing leadership bench in the church. Beside transformational leadership, it is also important to discuss adaptive leadership when realizing how church leaders should interact with a turbulent environment. Model of adaptive leadership Developed by Heifetz and Laurie (1997), the concept of adaptive leadership was presented as leadership based on the ability of leaders to be flexible, adaptable, and open to the working rules of their environment. Within the context of a fast changing Nigerian society where social ills like poverty, education and health inequalities are rampant, the capacity of leaders like Adebogun to handle the needs of the population with appropriate effective responses has been shown to be vital. He has involved personalized educational outreaching programs that are supposed to simultaneously solve the local issues and have also made WRFM interesting and accessible to younger generations that demand meaningful representation in

the community. Adebogun has been very loyal in his efforts to empower the youth through programs like scholarship programs, young mentorship, and literacy campaigns, which further proves the desire to change the lives of the young people and his efforts to see them get the much needed improvement and development.

In addition, the point where leadership and community life meet is also part and parcel of the growth of any church. Research has indicated that churches that flourish in the society today are the ones that have a good relations with the surrounding communities and engage the members in service programs actively (Ammerman, 2005). In his leadership, Oladega has guided the congregation through emphasis on social justice and humanitarian activities to bring in a paradigm shift in which the congregants were no longer passive consumers of their environment but agents of transformation. This transformation improves the identity of the church. Helps to develop a feeling of belonging and also a feeling of responsibility and common mission among members of the congregation. The assistance of Adebogun also involves associating with local organizations, raising the influence of the church on the community in the context of development projects. The article will help in filling an existing gap in the literature since we shall look at how dynamic leadership might have contributed to the WRFM growing significantly during Oladega Adebogun tenure.

METHODOLOGY

This qualitative investigation undertakes an in-depth examination of the transformative role of dynamic leadership in the remarkable growth and expansion of the World Revival Faith Ministry (WRFM), a burgeoning Christian organization led by the visionary Oladega Adebogun. Employing a case study approach, this research provides a nuanced and contextualized understanding of the ministry's leadership strategies, community engagement initiatives, and growth patterns.

The research design integrates various data collection methods, including participant observation, semi-structured interviews, and document analysis. Through prolonged engagement with the ministry, participant observation has yielded rich insights into the organizational culture, leadership dynamics, and community interactions that underpin WRFM's growth and development. This immersive approach has enabled the researchers to contextualize the findings within the broader framework of church expansion and community engagement. In addition to participant observation, semi-structured interviews have been conducted with a diverse range of stakeholders, including church leaders, congregation members, and community partners. These interviews have been designed to elicit detailed and nuanced accounts of the ministry's leadership and growth, providing a multifaceted understanding of the complex dynamics at play. The open-ended nature of the interviews has allowed participants to share their experiences and perspectives in a rich and contextualized manner.

Thematic analysis is utilized to uncover patterns and themes associated with dynamic leadership and church growth. This analytical framework enables the development of a



comprehensive understanding of how Adebogun's leadership has contributed to the ministry's expansion and impact. By situating the findings within the broader literature on church growth, leadership, and community engagement, this study provides a nuanced understanding of the role of dynamic leadership in facilitating sustainable community development and spiritual growth. The insights gained from this study have significant implications for church leaders, policymakers, and scholars seeking to promote sustainable community development and spiritual growth. By shedding light on the complex dynamics of dynamic leadership and church growth, this research contributes to the ongoing conversation on effective leadership and community engagement in the context of Christian ministry.

Biographical Overview of Dr. Oladega Adebogun and The mission and vision of world Revival Faith Ministry

Oladega Adebogun, the founder of the World Revival Faith Ministry (WRFM), is a local but prominent Christian leader in Nigeria. Born in Imota, Lagos State, as stated by Soneye (2025). Adebogun's early life was marked by experimentation and religious turmoil (Soneye, 2025). His life took a dramatic turn when he joined the Deeper Life Bible Church in 1985, where he gave his life to Christ and was mentored by Pastor W.F. Kumuyi (Soneye, 2025). This experience had a profound impact on Adebogun's life, leading him to pursue a path of service and leadership (Soneye, 2025). As he navigated his newfound faith, Adebogun also pursued higher education, earning a Bachelor's degree in Educational Administration from the University of Port Harcourt, a Master's degree in Educational Management from Lagos State University, and a Ph.D. in Educational Administration and Planning from Bayero University, Kano (Adebogun, n.d.; Soneye, 2025). Adebogun's academic background laid the foundation for his future ministry, which focuses on personal growth and social work (Soneye, 2025). Before establishing WRFM, Adebogun worked in various roles within the education sector, including as a Principal Inspector of Education in the Ministry of Lagos State (Soneye, 2025). This experience not only deepened his understanding of the education system but also fueled his passion for improving educational outcomes in Nigeria.

As a renowned educationist and entrepreneur, Adebogun has made significant contributions to Nigeria's education sector (Blacktalker, 2024; Adebogun, 2024). He is the proprietor and Managing Director/CEO of Caleb Group of Schools and Visitor to Caleb University, Imota, Lagos State (ISU@20, n.d.). Under his leadership, Caleb Group of Schools has grown into a leading educational institution in Nigeria, widely recognized for its commitment to academic excellence and moral values. One of Adebogun's most notable contributions to Nigeria's education sector is his scholarship programme, which has benefited numerous students (Adesulu, 2018; Adebogun, 2024). According to Adesulu (2018), Adebogun attributes his philanthropy to his experience as a child, when his poor family could not afford to send him to secondary school. Through his

scholarship programme, Adebogun has provided financial support to deserving students, enabling them to pursue their academic dreams. Adebogun's philanthropic efforts have earned him recognition and respect. He was appointed as a member of the International Youth Fellowship Advisory Committee and received the Pan-African Leadership Award as Icon of Societal and Human Capital Development (Black talker, 2024). These accolades are a testament to his commitment to empowering young people and improving educational outcomes in Nigeria.

The World Revival Faith Ministry was established by Oladega Adebogun on November 11, 2010. The ministry was originally begun in Likosi, Ogun State and is now headquarters in Lagos State to enable it to conduct more far-reaching evangelistic work yet still requiring to supervise the churches in Ogun State. This strategic choice is an indication of Adebogun being willing to spread the gospel and grow the ministry reach. Since he took over the position of the founder and general overseer of World Revival Faith Ministry, WRFM has been growing at an impressive rate with more than forty branches in Lagos and Ogun States by 2025. The leadership style of Adebogun is also marked by great emphasis on evangelism and discipleship, touching both points of zeal in preaching the gospel and real activities that will benefit the poor in the form of scholarship and enabling them to get jobs. These moves are associated with his thoughts that spiritual reform should also come along with some development in the society, thereby increasing the ministry influence and outreach.

The World Revival Faith Ministry (WRFM) has well-articulated mission and vision that are largely influenced by the leadership of Oladega Adebogun. His leadership has led to a dedication towards changing lives and communities by means of faith in Jesus Christ with a primary focus on evangelism as well as spiritual growth. The core vision of WRFM is to spread the gospel of Jesus Christ to all nations, tribes, and tongues through evangelism, believing in its necessity. According to Oladega, this vision transcends cultural and temporal boundaries, showcasing the universality of the gospel. Under his leadership, WRFM actively engages in outreach initiatives, including community events and large-scale preaching to diverse groups, sharing the message of salvation (Soneye, 2023). Such targeted strategy will make sure that the ministry not only carries out their commission to evangelize but also builds relationships with multiple communities, which is a value of inclusivity that the ministry adheres to. Besides the evangelism aspect, there is another main component of WRFM, which is to identify the possibility of establishment of new believers in the faith. Oladega describes how it is important to take care of individuals who want grow in Christ by making them get the support and guidance they require to mature in their faith. This is instituted in the form of discipleship programs whose aim is to mentor and teach the new converts in a way that creates the feeling of belongingness within church community (Soneye, 2023). In addition, the vision of WRFM takes into consideration a powerful focus on church planting. Oladega is committed to planting community-based churches that are founded on the Bible to make sure that Christians have

a designated worshipping place, fellowship and a place of ministry. This feature of the vision is essential in creating an all-embracing range of congregations that are capable of catering to the spiritual and social demands. The creation of these churches does not only entail individual spiritual growth but also community development and this is in line with the holistic vision of transforming the ministry (Soneye, 2023).

WRFM mission provides a real-world guide based on which its vision can be actualized and thus shaped significantly by leadership skills of the agency head in the person of Oladega Adebogun. It is the vision of the ministry to empower, teach, as well as train all the believers to evangelize society effectively and gain a triumphant life in Christ. The accomplishment of this mission occurs under extensive training programs where the members are offered the skills and tools needed to spread the word of their faith and be prepared to deal with the twists and turns of life with confidence (Soneye, 2023; Soneye, 2025). Oladega has also developed training that aid the production of capability in leadership and spiritual growth among the members, who then become adequate witnesses of Jesus Christ (Soneye, 2023). Education is also an important aspect of WRFM and it focused on sound biblical teaching that's inspirational and edifying to the members. Such a focus on education can empower believers to have a solid theological background and thus to be stronger in their faith and be able to handle day to day challenges. Oladega attested to the fact that biblical teaching should not only be relevant but practical with the mission of the ministry based on the truth of the Bible. Finally, the mission is backed by a strong sense of commitment in availing aid to the members to deal with different problems in life. WRFM is also providing counseling services, prayer support and outreaches based on spiritual and practical needs. The ministry under Oladega has also incorporated the need to build a healthy community where congregants get to find support and encouragement in the process of their spiritual journey (Soneye, 2023).

Reasons for the Growth and Expansion of the World Revival Faith Ministry

The World Revival Faith Ministry (WRFM) is a vibrant Christian organization with a dynamic leader Oladega Adebogun that has grown tremendously and evidenced this in its inward and outward part. Among the main reasons that have contributed to its growth are strategic models of leadership, comprehensive dedication to evangelism, intense emphasis on scriptural teaching as well as active work with the community. All these elements are important and necessary to maintain the flow of this ministry and increase its effectiveness.

Oladega Adebogun's leadership style can be characterized by a focus on empowerment, teamwork, and organization. He builds a system with clear roles and responsibilities, which facilitates accountability and efficiency that are very important in executing the objectives of the ministry (Soneye, 2023). This transparency is consistent with the values presented by Kouzes and Posner (2019) on the usefulness of straightforward communications and responsibility when it comes to great leadership. In addition to this, Adebogun also has invested in

leadership development by initiating different programs such as workshops, training programs, mentorship opportunities, and much more that focuses on providing the required skills to the emerging leaders so that they may be able to overcome challenges (Soneye, 2025). Such an emphasis on talent development will benefit not only WRFM in the strengthening of leadership, but also create a culture of evolution and learning. Studies have consistently indicated that successful leadership development is a key factor in determining the long-term success of an organization (Day, 2000), citing the reason why the ministry continues to expand under Adebogun. An emphasis on evangelism is at the core of WRFM philosophy, and it is something Oladega looks to as the key to the success of the ministry (Soneye, 2023). He also provides a culture of outreach in his congregation and this is highlighted as a way of insisting on his people, to reach out to those who have not yet experienced the love of Christ. The strategies that WRFM uses in evangelizing as headed by Him include personal evangelism, street evangelism, community outreach and open-air crusades that are mentioned by Mattson (2020) to be effective in church growth. One of the pillars of growth of WRFM has been its adherence to good biblical instruction (Soneye, 2025). Oladega states that spiritual transformation starts with a good knowledge of Scripture. As a result, he also emphasizes intensive theological teaching by providing frequent Bible studies, Sunday school classes, and discipleship programs that can immerse the members of the church in biblical doctrines.

Towns et al. (1981) suggest that a church that takes theology content seriously is likely to develop a group of wiser and committed congregants. The scriptural literacy help to empowers members to practice scriptural principles in their day to day lives and this increases their spiritual growth and ability to guide others. This method of education plays a huge role in the development and expansion of the ministry. Regardless, Oladega is cognizant of the need to meet the social-economic needs of the community and provide spiritual outreach (Soneye, 2023). WRFM is also actively involved in numerous humanitarian activities which include: educational program, health programmes, and vocational training programmes to cater to the unprivileged individuals. These initiatives also prove that the ministry wants to put into practice, i.e., to prove the love of Christ through deeds, as Keller (2016) notes that the combination of the spiritual and the social aspects of ministry is the key to successful outreach. All of these, combined with powerful leadership, fervent evangelism, strong education, and powerful community service give a complete ministry strategy that characterizes WRFM under the leadership of Oladega. This synergy, coupled with meticulous attention, not only enhances WRFM's competence in executing its mission but also sets a commendable example for other ministries striving for impactful outcomes. By leveraging these complementary elements, WRFM is able to navigate challenges and adapt to changing circumstances while remaining steadfast in its commitment to transforming lives through faith.

The World Revival Faith Ministry (WRFM) with Oladega Adebogun as its leader is keen on promoting holiness and ethical standards in the congregation. This emphasis is not only

contained to the church and its spiritual well-being but also to the more general mission of the church in the transformation of the community. The biblical basis of the teachings of the ministry regarding holiness is fundamentally embedded in the teachings of Jesus Christ, which reflects in WRFM's approach, therefore informing the members of the ministry in their day to day life, in their relationships and how they relate with the community. The core tenet of living a God honoring life that include living a holy life is central to the identity of WRFM. Oladega Adebogun instructs that, holiness is not a set of rules to follow but the way of life that can show the relationship a person has with God. This dogma is based on the Scripture which emphasizes the necessity of personal sanctification as well as moral integrity pursuit (Hollinger, 2018). The WRFM ministry teaches its members to consider the teachings of Jesus and use them in a way that attainable and transformative version of holiness can be achieved.

WRFM adopts a holistic approach to holiness, requiring not only a personal commitment to ethical living but also a collective effort to create a supportive community. As Adebogun emphasizes, the church serves as a nurturing ground where individuals can grow in their spiritual and ethical commitments, a statement supported by Daloz (2018). Such environment fosters accountability and encourages members to support one another in their spiritual journeys, reflecting a strong communal ethos that fosters growth and resilience among congregants (Foster, 2011). Adebogun's leadership strongly advocates for ethical behavior grounded in biblical teachings, significantly impacting the congregation's approach to various aspects of life, including honesty, integrity, and responsibility (Soneye, 2025). The ministry offers teachings and workshops designed to equip members with the moral frameworks necessary to navigate challenges in their personal and professional lives. Such programs help congregants align their actions with the principles of faith, leading to a profound transformation in their conduct (McManus, 2013).

Besides, WRFM fosters self-reflection and moral reasoning among its members as a way of evaluating members' behavioral choices. This tradition is in line with the theological belief of repentance and renewal by allowing the congregants to develop spiritually, while aggressively fighting against societal norms that stand against the Christian traditions (Bennett, n.d.). As Bennett notes, "Repentance acknowledges the final authority of God's law and acknowledges that God's law must be fulfilled" (Bennett, n.d., p. 1). This understanding is central to the Christian tradition, guiding believers to live in obedience to God's Word. In many cases, as Wright (2010) observes, living ethically would be more of an outward reflection of being faithful and this would help a congregation have a better sense of integrity and witness to the community at large. The tendency of WRFM to promote holiness and the ethical way of life will appeal to the wider pentecostal movement as it focuses on the personal sanctification and moral rectitude. The values, which Adebogun emphasizes, correspond to those voiced by powerful representatives of Pentecostalism who promote the ways of life, marked by the work of the Holy Spirit (Pinnock, 2019). Holiness here now becomes an individual and a corporate task that strengthens the witness of the church in the

society. The more the members are devoted to ethical living, the more the influence will not only be with the members, but will also be felt in the society as a whole. Adebogun's sermons on holiness and social responsibility reflect a commitment to social justice and community involvement, encouraging congregants to live out their faith in practical ways (Soneye, 2023; Soneye, 2025). This aligns with the emphasis on social justice and community care found in Timothy Keller's work (Keller, 2016), highlighting the importance of living a life that reflects biblical values in every aspect. This has been combined with the overall view of the Pentecostal movement which is to help people live morally and also bring change to the community which has underlined WRFM as transformative in motivating people to live righteous lives and changes in their communities which is the greater stipulation in the Bible that followers of Christ should influence their societies positively (Stetzer, 2013). Concern with holiness and ethical living also extends to community activity. WRFM urges its members to engage in social and humanitarian projects which shows their being faithful towards ethical purposes. Such activities normally comprise of out-reach programs that would aim at helping the marginalized, aid education as well as offer resources to needy individuals. Such community transformation initiatives create good associations among the church and the neighboring communities. As the ambassador of WRFM introduces other people to service and encouragement activities, they generate the possibility to model and proclaim the work of the Gospel, the power of a life transformed, as supported by scholar (Roberts, 2017), which also magnifies the ministry, as a whole. This twofold concern with individual sanctity and social action is indicative of the ministry to build a faith that is willing to work towards the well-being of others and this is in fulfillment of the biblical injunction to love thy neighbor as thyself (Matthew 22:39).

Social Responsibility, Humanitarian and Economic Projects

The World Revival Faith Ministry (WRFM) has impressive leadership through Oladega Adebogun; Social responsibility has become a main feature of the mission of this institution. This devotion does not limit itself to any spiritual talks only but applies in a broad humanitarian outreach and economic empowerment activities geared to the current needs of both its congregation and the general community at large. The multifaceted approach of WRFM demonstrates a comprehensive way of thinking, acknowledging that spiritual development is intertwined with social and economic factors that individuals face daily. Under Adebogun's leadership, WRFM has undertaken several notable humanitarian and social initiatives, including:

WRFM offers scholarship opportunities to students at Caleb University in Imota, Lagos State, specifically targeting church members of the church who have been attending the church for six months to one year member. Through this initiative, they have the opportunity of sponsoring studies in Christian Religious Studies Education with full tuition fees, accommodation and other miscellaneous being fully paid (Adebogun, 2024). These projects are essential in terms of

developing the communities because education is a significant tool of empowerment and through education people have a chance to gain knowledge and become skilled to become successful in any profession they plan to have and also be able to make a positive change in Society. The ministry has made major moves through putting up the Faith Theological Seminary which offer free theological education not only to its members but also to non-members (Adebogun, 2024). The inclusive philosophy guarantees that a wide range of people, despite their financial status, is able to attain high level of theology education. Many of the graduates have been giving powerful testimonies of how they have been transformed both spiritually and in their lives, are better equipped in their Christian faith and are capable of spreading the message of the Christian faith without any fear. This dedication to education does not only make informed leaders but is one of the doctrines of equipping the believers that is central to effective ministry and fulfilling the Great Commission (Stetzer, 2013; Pinnock, 2016). In an effort to enhance community uplifting and economic empowerment, WRFM has come up with a program that gives less privileged people some startup capital to start and carry on with small business. This financial support can be especially important in low-income communities, in which access to money resources can be very limited in those areas. These programs are crucial to promote economic self-sufficiency among the congregants and are most in line with social and economic development agendas at large. WRFM provides free transportation bus assistance to members and converts on Sundays, enabling them to attend the church headquarters located a few kilometers away. This initiative eliminates logistical challenges and geographical barriers to communal worship and other church activities, particularly for members dwelling on the outskirts of town. By offering bus services at no cost, WRFM promotes inclusivity and accessibility, making members feel like part of the of the church community. This is accompanied by the significance of bodily worship in the church that can greatly boost the spiritual experience by means of collective meetings. WRFM also sponsors free transportation, accommodation, and meals for attendees of major programs, such as those held in December, April, and August. This hospitality initiative enhances audience engagement and enables people from all walks of life, including those from less privileged backgrounds, to fully participate in church worship and activities. Moreover, this project reflects Christian values of compassion and kindness, highlighting the need to be supportive of one another, as supported by Roberts, S. B., & Ashley, W. W. C. (2017).
